Client agrees to pay a non-refundable deposit in the agreed upon amount to reserve event date. Brad's Karaoke & DJ holds reservations for 10 days to allow mailing time of deposit. The remaining balance is due and payable 2 weeks prior to the event unless noted otherwise. Brad's Karaoke & DJ will not set up any equipment or provide services until full payment is received. Payments made after due date are subject to a \$25.00 late fee. Client shall fill out and keep a contract copy for their records. Client shall then sign and return an additional contract copy with the deposit to: Brad's Karaoke & DJ. Endorse all checks or money orders payable to Brad Bennett, 4464 Bakersfield Drive, Nesbit, MS 38651. Client agrees to provide a grounded standard 3 prong, 110 volt electrical outlet within 40 feet of the provided set up location. If electrical power is unavailable, Generators can be provided per request ahead of time for an additional fee of \$125. Client also agrees (only upon DJ request) to provide one table with table cloth and chair. By signing, the parties acknowledge and confirm that they have read, and agree to the terms, conditions and all sections set forth in this agreement. Additional payment terms: There will be a \$25.00 fee charged for all returned checks. Clients are welcome to add gratuity for the entertainer depending on service provided. Cancellation: This agreement cannot be cancelled or modified except by the client or Brad's Karaoke & DJ and only then, if terms are mutually agreed upon. In the event of a cancellation, the client agrees to give a 45 day written notice and forfeiture of the deposit. If a 45 day written notice is not given, the client agrees to pay the remaining balance of the entire contract price. Rescheduled events are subject to availability. In the unlikely event that the DJ is unable to perform or attend the event and a replacement cannot be available, Brad's Karaoke & DJ will provide full refunds of any deposits and/or other payments made by the client. Please note: Brad's Karaoke & DJ is a one man operation and has successfully provided service at hundreds of events. Thankfully we have never missed one single event at the last minute due to an uncontrollable circumstance such as: sudden accidents, sickness, death or any other types of unfortunate occurrences. However, it is highly recommended that the client have a contingency backup plan available with any sound equipment and/or special music needed for the event. The client agrees that the refund will be the full extent of damages that they are entitled to and no further damages may be sought against Brad's Karaoke & DJ. If litigation for any item in this contract is necessary for collection, Brad's Karaoke & DJ shall be entitled to all reasonable attorney fees, court costs and collection expenses. The invalidity of any provision of this agreement shall not affect the validity of any other provision. Overtime Costs: Whenever possible, requests for extended playing time during an event will be accommodated. However, availability of the designated entertainer(s) beyond contract time cannot be guaranteed by Brad's Karaoke & DJ. Overtime may be requested in increments of one hour at a rate of \$125.00 per hour unless otherwise agreed upon. Payments for overtime are due on date of event and shall be made with cash only. Additional Provisions: The client shall ensure that the performance facility is open and available at least 2 hours prior to the scheduled "start time", and that the performance facility meets all federal and state safety regulations. For outdoor performances, the client shall ensure adequate shelter is provided to protect Brad's Karaoke & DJ equipment from adverse weather conditions. Neither party shall be responsible for personal injury, property damage and or loss except to indemnify and hold each other harmless from any claims, loss, costs or damages incurred arising from personal injury or property damage caused by the acts or omissions of the responsible party's students, employees, agents, contractors or subcontractors. Brad's Karaoke & DJ personnel reserve the right to deny any guest access to supplies or equipment. In the unlikely event Brad's Karaoke & DJ performance is delayed, liability is limited to providing client performance time equal to time lacking.
